

The Problem Defined




Physics proves the Inflow ratio sets the **Atmosphere ratio** of human to natural CO2. But UN says natural CO2 stayed at 280 and human CO2 caused all increase.


The simple physics model is correct

Inflow ratio sets Atmosphere ratio Human CO2 adds only 18 ppm




We follow the Scientific Method



If your Prediction is wrong, your Theory is wrong.


14C-CO2 data show constant half-life



Half-life (*Th*) = 10 years

Residence Time (*Te*) = 14.4 years

Physics System for Atmospheric CO2



Applies to all definitions of CO2

Physics theory: Outflow = Level / Te

$$dL/dt = Inflow - Outflow (1)$$

$$dL/dt = Inflow - L / Te (2)$$

$$dL/dt = Lb / Te - L / Te (3)$$

$$L(t) = Lb + (Lo - Lb) exp (-t / Te) (4)$$

Physics theory conclusions

Balance level = Inflow * Te:

Lbh = 4.6 (ppmv/year) * 4 (years) = 18 ppm (1)

Lbn = 98 (ppmv/year) * 4 (years) = 392 ppm (2)

Inflow ratio sets Atmosphere ratio:


Lbh / **L**bn = 4.6/98 = 18/392 = 0.046

Physics model exactly predicts 14C data



Physics Model Summary


One simple idea: Outflow = L / Te

Exactly computes 14C-CO2 data

Inflow ratio sets Atmosphere ratio


Human CO2 adds only 18 ppm

UN theory assumes nature good, human bad



UN theory treats natural and human CO2 differently

UN uses demon to trap human CO2 which violates Equivalence Principle



UN core argument fails logic


UN says, from 1750 to 2013:

- 1. Human CO2 emissions totaled 185
- 2. Atmospheric CO2 increased 117
- 3. So, human CO2 caused ALL CO2 increase above 280, the level in 1750

Natural CO2 emissions totaled 26,000



UN claims, since nature absorbs human CO2, it can't increase natural CO2




But human outflow of 4.6 cannot restrict nature's inflow to 98

UN claims human CO2 reduces "buffer capacity of carbonate system"




UN theory fails correlation test

UN claims annual human inflow causes annual change in CO2 level




Munshi (2017) statistics show correlation of annual human inflow with CO2 level is ZERO. So, no cause-effect




Bern model shows UN climate models trap 15% of human CO2 L(t) = Lo [+ 0.150] $+ 0.252 \exp(-t / 173)$ + 0.279 exp(-t / 18.5) $+ 0.319 \exp(-t / 1.19)$

For natural inflow, the Bern model predicts: 0.15 *100 ppm/year *1000 years = 15,000 ppm

Bern model can't simulate 14C data



Bern model depends on history




UN theory fails physics

No defined system and no core math Arguments violate physics and logic


Can't predict 14C-CO2 data Invalid prediction that uses history

Physics theory is right - UN theory is wrong



UN cannot explain how natural CO2 stays at 280, while human CO2 adds 130 to atmosphere.

Natural and human CO2 set balance levels



Atmospheric CO2 is like water in a lake

Human and natural CO2 flow into and out of the atmosphere like water flows into and out of a lake.

Inflows do not accumulate. Inflows set balance levels where outflow equals inflow and level is constant.

Natural CO2 adds 392 ppm

Human CO2 adds only 18 ppm

Nature dominates the rise in CO2

Human CO2 does not change climate
